Both facilities provide temporary lodging to families of critically ill children who must leave their own communities to seek medical care for their children - the Westmoreland House in close proximity to Strong Memorial Hospital and the House Within the Hospital physically located within the hospital. Both facilities serve families of children receiving treatment at the Golisano Children's Hospital at Strong and the Westmoreland House serves families with children in treatment at all other medical facilities. In 2010 the Ronald McDonald Houses provided a total of 1,185 family lodging periods, which includes multiple stays for some families. Families came from 19 counties

4b (Code: ) (Expenses \$ 194,951. including grants of \$ 89,326. ) (Revenue \$ ) GRANT MAKING - The Organization's mission is to create, find, and support programs that directly improve the health and well being of children. While the Ronald McDonald House and the House Within the Hospital are its cornerstone programs, the Organization recognizes that their intensive support can reach out to only 27 families at any given time. To meet its broader mission, the Organization also provides grants to nonprofits in the greater Rochester, New York area. In 2010 grants from the Organization to 15 organizations provided support to over 7,200 children. Money used for grant making comes from special promotions held by local McDonald franchises, special designated fundraising activities and a matching grant account funded by the National Chapter of Ronald McDonald House Charities in Oak Brook, IL.

We accomplish our mission by caring for families and keeping them close to their children at our 20-bedroom "home away from home", caring for the parents of the most critically ill and injured children at our House Within the Hospital, located above the Pediatric Intensive Care Unit at the Golisano Children's Hospital at Strong, providing a Family Lounge on the Pediatric Floor at the Golisano Children's Hospital at Strong that brings the caring spirit of our two Houses to all families with children in treatment and funding programs that improve the health outcomes for children in our area.

The Ronald McDonald House (the "Westmoreland House"), is a 20-bedroom facility that provides temporary lodging to families who must leave their own homes to seek medical care for their children. In January 2005, the Organization opened an additional facility, a 7-bedroom "House Within the Hospital," at the Golisano Children's Hospital at Strong, for families of critically ill or injured children receiving treatment at the hospital. The Organization also makes grants to nonprofit organizations that improve the health outcomes of children in the Greater Rochester community.

area medical facilities.

Families of critically ill children age 18 and under are eligible to stay at both facilities. They must be referred by a physician and be undergoing inpatient or outpatient care at a medical facility. For the Westmoreland House, a nominal donation of \$10 per night per family is requested, which only partly defrays actual operating costs. However, no family is ever turned away if they cannot afford payment. No room donation is requested at the House Within the Hospital. The House is an approved lodging facility for families covered by Medicaid.

Funds are solicited through the Heartbeats newsletter published twice a year. In-kind donations of goods and services valued at over \$591,930 were received in 2010. This amount excludes the value of volunteer hours noted below. Major in-kind donations include waste disposal, long-distance phone cards for guests, beverages (milk and soda drinks), daily newspapers, carpet cleaning, cleaning supplies, household paper goods, pagers, home cooked dinners 4-6 days a week, books and games, and retail space and supplies for special events.

A large group of volunteers help to support the Organization's staff and guests by providing housekeeping, office assistance, gardening, solicitation of in-kind goods, and repair and maintenance of the facilities. Volunteers provided approximately 46,200 hours of service to the Houses in 2010, which dramatically reduced the need to hire staff to complete the many varied activities.

The Organization reviews its strategic plans on a continuing basis. In

the past, this review has identified areas for potential program expansion both inside the Houses and in the broader community the Organization serves, leading, for example, to the establishment of the House Within the Hospital. It has also helped the Organization enhance service delivery of its existing programs.

The proposed merit increase took into account overall performance as well as comparables.
